The Fascist Art Market before, during and after the Rome-Berlin Axis

Der italienische Kunstmarkt im Faschismus vor, während und nach der Achse Berlin-Rom

convened by PD Dr. Christian Fuhrmeister, Munich, and Prof. Dr. Donata Levi, Udine

The aim of the workshop is to assemble both qualified researchers and doctoral students to jointly analyze a field that requires transnational (and transdisciplinary) approaches. The Italian art market in the 1930s and 1940s is a topic which has not been thoroughly researched so far. The workshop intends to explore both the internal dynamics of the art market (role of dealers, collectors, experts and art historians) and the relevance of political and economic instances.

All individual contributions should be concise and succinct: Ideally 10 minutes, but definitely no more than 15 minutes, and supported by adequate visual or archival material or appropriate data (visualizations). The focus of the workshop is on intense discussions among all participants.

German, Italian, English – all three languages are considered proper working languages of the workshop, and all participants are required to understand (not: to speak perfectly) all three languages. We assume, however, that most interventions will be in English.
